## Narrative

This report is based off of memory recollection.

1) I Officer Schmidt was dispatched to an unwanted subject call at 2600 46th Ave SE at approximately 1716 on 07/19/2025. The dispatched report stated that there were a male and female doing questionable things under a blanket and that there were \*Redacted\* near them that were unknown if they were the parents to them.

2) I arrived on scene and was met by the RP who I identified as Elydia Symens DOB: \*Redacted\*/2004 who stated that she was the manager at the park. Elydia stated that she was made aware from a separate family that a man and a woman were making hand movements under a towel that resembled sexual activities. Elydia stated that she had located the male and female sitting under a blanket at a table near other \*Redacted\*. Elydia stated that she approached the individuals

and "did see them doing that" and had told them to leave the property. Elydia stated that they then left, went to the vehicle, started yelling at each other, and then came back onto the property. I then asked Elydia what the hand gestures suggested was going on under the blanket and she stated that he was "fingering her" and she was "giving him a hand job". Elydia stated that there was a child sitting next to them at the picnic table. Elydia stated that she did not want charges and just wanted them removed from the park.

3) Elydia pointed out a male that was walking across the park. While approaching the male Elydia identified the female party as swimming in the pool nearby. I observed the male talking to that same female shortly prior to me approaching him. I spoke with the male and requested that he leave the premises immediately. The male asked me why and I explained to him that he had already been told to leave by staff and that he knew why I was there. I did not want to embarrass the male or cause a scene, and I told the male that if he did not know why, or if he wanted me to state the reason out loud that I would but that I believe that he knew why I was speaking to him and that for his respect, I would keep it discreet. The male complied and collected his things. I then walked over to the female who had started to go around the lazy river once more due to passing the exit and I yelled at her to get out of the pool at the next exit.

4) I walked with the male to the front exit where we stood and waited for his wife. The wife followed soon after and questioned what was going on. The wife attempted to state that they were only kissing and did not want officers to make a big deal out of it. The wife stated that they had 3 \*Redacted\* in the park and would gather the rest of their belongings and \*Redacted\* and leave but that she really did not want to make a scene.

5) I identified the male party as being Shannon Copas DOB: \*Redacted\*/1975 and the female being Aimee Copas DOB: \*Redacted\*/1976. It should be noted that due to not wanting the \*Redacted\* to see their parents being engaged by law enforcement, the \*Redacted\* were not identified and were just observed leaving the premises.

This report is based off of memory recollection.

1) I Officer Schmidt {300} conducted follow up on this case at approximately 1330 on 07/24/2025. I called Raging Rivers to request any possible security footage of the event as well as possible names of family's that may have seen the incident or have come forward to them.

2) I spoke with three different employees who continued to transfer me to higher ranking people until I was put on the phone with the Ragin Rivers manager, David. I had not told any of the previous employees about the incident I was referring to for footage, but they continuously stated 'That day' as if they already knew what footage I was looking for. I stated to David who I was and that I was wondering if he would be able to pull footage for me, and he instantly stated that the cameras were deactivated that day. I asked what day he was referring to and he stated "this Saturday" which was 07/19/2025. I asked if he was referring to the event of the possible sexual activities occurring and he stated yes, and continued to state that the cameras' WIFI was down and that they had no footage from any of the cameras that day.

3) I asked David if he knew any of the names of the family that had first reported it to Lydia and he stated that the family did not want to give out their names. I then asked if anyone had come forward with more information or names and he stated no. I have completed a CID submission form to pass the case off for further review.
